

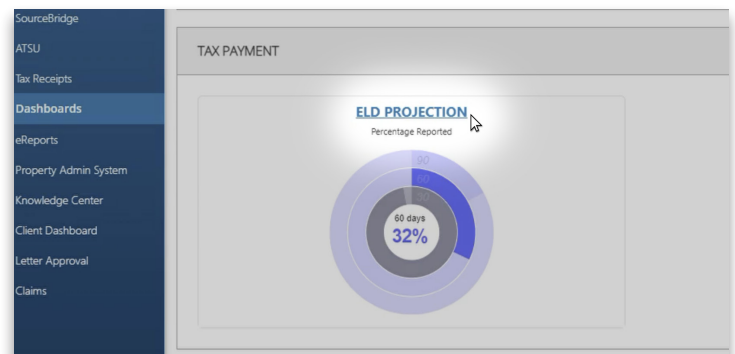


# Economic Loss Date (ELD) Dashboard

This powerful dashboard inside your DigitalTax Portal shows you the percentage reported on agencies with an ELD in the next 90 days. From there, you can identify the open items shown in just a few clicks.

## Easy Navigation

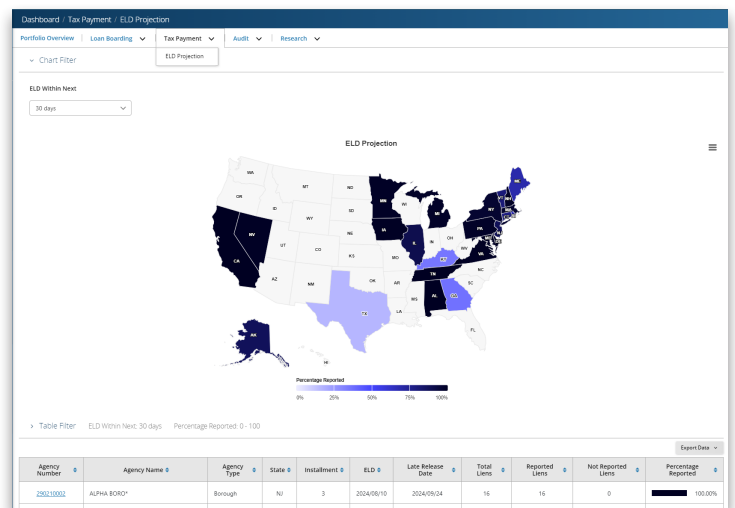
Portfolio Overview gives you inventory statistics and access to the dashboards. From here, simply click ELD PROJECTION. The ELD projection dashboard shows the percentage reported for agencies with an ELD due within 30 days, 60 days, and 90 days.
