


 Confidence levels are calculated based upon the amount of data coverage available on the property to perform the "digital abstract". The higher the amount of data available (e.g., variety of document types, depth of chronological records, etc.) the higher the confidence grade.




Special Liens (or pseudo-liens) are not typical mortgage or home equity instruments and tend to have priority over those kinds of standard liens. Common types are:


